Following the introductory period, your rate will change to our going rate of 9.90% APR for the BFCU VISA Platinum card. On new cards, the 2.20% APR is good for 12 months from date of first balance transfer or first purchase, whichever comes first. For existing card holders, the introductory APR applies to non-BFCU balance transfers and the rates are valid for the next twelve billing cycles. The introductory APR does not apply to cash advances. We apply your minimum payment to balances with the lower APRs first. Amounts paid over the minimum payment will be applied in the order of highest to lowest APR balances. Must apply for card by February 25, 2022 and transfer balance by March 31, 2022.
